Dear Bruno, **you have announced the Grange Committee has agreed COVID-19 vaccinations will be mandatory to attend The Grange Golf Club** (excluding those with a written medical exemption or if the member or visitor is under the age of 12 years), from 21 December 2021. (Your email dated 3 December 2021, copy attached.)

**Bruno, both you and your fellow Grange Committee members have taken a very big step in seeking to influence the personal health care decisions of people attending the Grange Golf Club, including fee-paying members.**

**On what authority have you made this COVID-19 vaccination mandate without informed consultation with members and staff?** I have previously requested the scientific and medical sources/references the Grange Committee is using to justify pressuring people to have COVID-19 injections to attend The Grange Golf Club, but so far this information has not been forthcoming. (See my email to Barry Linke dated 19 November 2021, below.) **It is incumbent upon you to provide this information for public perusal.**

**The COVID-19 injections are 'leaky vaccines' which do not prevent infection nor transmission. The purported 'protection' provided by these experimental injections has shown to be of limited duration, and now 'boosters' are being promoted, potentially for life.** For example, in the United Kingdom, the minimum gap for COVID-19 'boosters' has been halved from six monthly to three monthly because of the failure of these injections to provide proper immunity to COVID-19, see: **UK's minimum gap for Covid booster jabs to be halved to three months**. Are people facing multiple 'booster' shots every year? Consider that **the Morrison Government has announced** "Through continued engagement with Pfizer-BioNTech, the Government has secured 60 million doses in 2022, and 25 million doses in 2023. Delivery will begin in the first quarter of 2022 and **enable booster coverage throughout the year**". (My emphasis.) According to Minister for Health and Aged Care, Greg Hunt, "More than 280 million doses of COVID-19 vaccines have now been secured to support the COVID-19 vaccine roll-out". **280 million doses for a population of 26 million...** And **\$8 billion of taxpayers' dollars** has so far been invested in the Morrison Government's COVID-19 vaccine rollout.

Obviously, the claims being made for the effectiveness of these injections are very much open to question, with umpteen 'boosters' now in the offing. The COVID-19 injections are 'provisionally approved by the TGA', and the TGA is relying upon manufacturers' data and post-market assessment to judge the effectiveness and safety of these products. 'Post market assessment' indicates people being injected in the community are part of the clinical trials assessing these products, as admitted by Greg Hunt, i.e "The world is engaged in the largest clinical trial, the largest global vaccination trial ever..."

**Who has given their 'informed consent' to participate in this 'largest global vaccination trial ever'?** Informed consent is shaping up to be a very controversial subject as I suspect no-one has truly given valid informed consent before these fast-tracked experimental medical interventions. For instance - **how many people knew they were being set up for a potential lifetime of 'boosters'?** This is a matter I'm pursuing with AHPRA, the regulator of health care practitioners, and others. **AHPRA has confirmed to me** that "Practitioners have an obligation to obtain informed consent for treatment, including vaccination. Informed consent is a person's voluntary decision about health care that is made with knowledge and understanding of the benefits and risks involved".

Many people have been coerced into having COVID-19 injections to keep their jobs - how can this be a 'voluntary' decision? And now golfers are being coerced into having COVID-19 injections to play golf. These vaccination mandates are spreading across society.

**What exactly is 'the emergency' being used to justify this intrusion on people's bodily autonomy?**

Over the past 22 months 5.2 million deaths have been attributed to COVID-19 globally.[1] This is in a global population of 7.9 billion, where around 60 million deaths would be expected annually[2], so around 110 million deaths would be expected over 22 months. Deaths attributed to COVID-19 must be seen in this context, including that categorisation of deaths 'of' covid or 'with' covid is controversial. Independent and objective retrospective critical analysis is required to investigate deaths and 'case' statistics, and the basis of this so-called 'pandemic'.

Despite the incessant fear-mongering from the corporate media and taxpayer-funded ABC and SBS, and from Chief Health Officers and politicians and others, most people aren't at serious risk of COVID-19. For example, the WHO acknowledges "Most people infected with the virus will experience mild to moderate respiratory illness and recover without requiring special treatment." (See attached.) While the WHO says "...some will become seriously ill and require medical attention", **it seems most people won't become seriously ill and require special treatment.**

For most people COVID-19 is not a serious risk, particularly for healthy children and young people. In her **letter to the South Australian Commissioner for Children and Young People**, Emma McArthur notes the risk of dying from COVID-19 for children is close to zero and it is less dangerous to them than influenza. They are also less likely to get symptoms of COVID-19 and a vast body of literature shows that children are **not major drivers of transmission**. **While older people might be willing to have regular COVID-19 injections, these potentially regular medical interventions are highly questionable for healthy younger people with their lives ahead of them, disrupting their natural innate immunity with who knows what long-term consequences.**

**With such low risks for most people, why are mass populations being coerced to be vaccinated with defective COVID-19 'leaky vaccines'? This is the big question...** Why are the Morrison and State Governments so determined to have ever-increasing vaccination targets, now heading towards 95%? From a public health perspective it makes no sense as the COVID-19 injections do not provide sterilising immunity and most people are capable of mounting their own effective immune response. **But now a massive and highly lucrative multi-billion dollar repeat COVID-19 injection market is being created, plus vaccine passports are being put in place which have significant implications in regards to population control and surveillance aka a social credit system.** These are important political issues which require urgent investigation, along with considering the potentially deleterious long-term consequences of implementing this unprecedented experimental mass population vaccination rollout.

**In the meantime Bruno, you and your fellow Grange Committee members are demanding that most people over 12-years-old attending The Grange Golf Club submit to the COVID-19 injections, interfering with their own evaluation of the risks and benefits of these medical interventions in regards to their own age and health status. You are setting people up for a lifetime of these medical interventions/'boosters' and possible dependence upon the vaccine industry, with 'vaccines' of unknown effectiveness and safety.**

As you and the Grange Committee have now taken it upon yourselves to mandate COVID-19 'leaky vaccines' for other members, staff and visitors to the Club, I will be forwarding more information to you to consider on this matter. As previously requested, **please provide me with the scientific and medical sources/references the Grange Committee is using to mandate COVID-19 injections for people to attend The Grange Golf Club.**

This email is copied to politicians and others as witnesses to the creeping vaccination mandates across society, and discrimination against those refusing to submit to the defective 'leaky vaccines', and will be circulated to others for information.

Barry, re the email below from Grange president Bruno Battistella, in which he says "**we strongly encourage all members to get vaccinated as soon as possible**" and that "**in due course, it may also be a requirement that anyone entering the Clubhouse be vaccinated**".

**Presumably the Grange committee is aware the COVID-19 'leaky vaccines' do not prevent infection nor transmission, and apparently have limited duration of 'protection', with 'boosters' now in the offing against this disease which, before the implementation of COVID-19 injections, was known to not be a serious threat to most people. But there is much that is unknown about these fast-tracked experimental COVID-19 injections, including the impact on the natural immune response and long-term cumulative consequences.**

Barry, I've been keeping you in the loop with much of my correspondence on the grossly disproportionate and ill-targeted global COVID-19 response, so you should be aware of what is at stake here, see many of my emails on my website: [vaccinationispolitical.net](http://vaccinationispolitical.net)

**I suggest the Grange committee needs to be very careful about interfering with Grange members' personal health care decisions.**

Please provide your urgent response to the following:

- Please provide me with the specific scientific and medical sources/references the Grange committee is using to "**strongly encourage all members to get vaccinated as soon as possible**".
- **Have you had legal advice on this move by the Grange Golf Club**, i.e. to seek to interfere in the personal health care decisions of Grange members, **members who cover a broad range of ages and health status?** In this regard please consider the definition of 'informed consent': "**Informed consent is a person's voluntary decision about health care that is made with knowledge and understanding of the benefits and risks involved.**" Please see **the response** I received from AHPRA, the regulator of health practitioners, confirming the definition of informed consent, copy attached.
- **What is the Grange Golf Club's insurance position in regards to 'strongly encouraging' medical interventions, for both members and Grange staff?**

**I request your acknowledgement of receipt of this email and your urgent response to my questions.**

Golf Australia representatives have been copied into this email, as presumably other golf clubs around Australia are also now taking steps to make medical recommendations to their members. This matter needs very serious consideration.

## Presidents Message

We at The Grange have been leading the way throughout this entire COVID-19 pandemic enabling the Club to remain open and members being able to continue playing golf, even with certain restrictions. We thank Members for their patience and understanding during these difficult times. We will continue to be one of the leading clubs in SA whilst looking after the best interests of our Members and staff.

As many of you would be aware, South Australia is opening its borders on Tuesday 23<sup>rd</sup> November 2021 with travellers able to enter the State. Despite these changes, the Club, and your Committee endeavour to continue providing a safe and enjoyable environment for Members. Member's health and wellbeing is our top priority.

The vast majority of our staff are now vaccinated, and we will soon achieve 100% vaccination for all Clubhouse, Admin and Pro Shop staff.

At this stage, with golf being a non-contact outdoor sport, and Members having a choice as to who they wish to play with, your Committee have decided to not mandate vaccinations for members. However, this may change in the future and hence **we strongly encourage all members to get vaccinated as soon as possible. Note that, in due course, it may also be a requirement that anyone entering the Clubhouse be vaccinated.**

With new requirements coming into effect, in the event of an outbreak and our commitment to maintaining our current standards of service to members, we reconfirm the following requirements when at the Club:

- Members and guests must register with the QR code when entering the Clubhouse, Pro Shop and Gym. Note that each of these areas have separate and distinct QR Codes so you must check in when entering each area.

- Members are **required** to wear a face mask when inside the Clubhouse and Pro Shop. Masks can only be removed when sitting to eat and drink but must be worn when getting service from the bar or deli.

We are also firming up the wearing of face masks at the Club and introducing a **no mask, no service policy** in the Members' Lounge, Pro Shop and Administration.

In the event of an outbreak and the need to quarantine, staff will be rostered in two shifts where possible to ensure the Club remains open and essential work can continue on the golf courses.

Members are reminded of the current requirements for our hospitality areas:

- Indoor densities (unless it is a private function) are calculated at three people per 4m<sup>2</sup> providing patrons are seated. Private functions (including weddings and funerals) are calculated at one person per 2m<sup>2</sup>.
- All indoor consumption of food and drink must be done while seated unless it is at a private function.
- Outdoor densities will be calculated at one person per 2m<sup>2</sup>. Outdoor consumption of food and drink can be undertaken while standing.

In addition, Members are reminded of good practices that have been adopted by The Grange during the pandemic, including:

- Stay 1.5 m away from others adhering to social distancing signage
- Use hand sanitiser provided regularly
- Stay at home if you are unwell
- Get a COVID-19 test if you have any of the following symptoms: fever or chills, cough, sore throat, runny nose, shortness of breath and loss of taste or smell

As we know with COVID-19, things change quickly, and we will continue to monitor the situation very closely and react to any government decisions as they are made. Should anyone have any specific Club concerns or wish to discuss further, please do not hesitate to contact our General Manager on 8355 7100. To date, we have been very fortunate here at The Grange, and in South Australia, and we thank Members for helping keep us all safe.
