## Call for urgent examination of vaccination policy, including the Covid-19 jab rollout

**Gerard, the current insane plan to repeatedly jab everyone aged five years and older with defective Covid-19 injections, that don't prevent infection nor transmission, against a disease it was known from the beginning wasn't a serious threat to most people, calls for the spotlight to be shone on the process for approving vaccine products for the taxpayer-funded schedule.**

There are many conflicts of interest in taxpayer-funded vaccination policy to investigate and expose. It's essential that this matter come out into the open before the federal election, likely to be held in May 2022, particularly in light of the Morrison government's mass population Covid-19 jab rollout, and mandatory Covid-19 jabs being imposed around Australia by state and territory governments, and employers and businesses and others.

**This is a global emergency Gerard...the real emergency is the torrent of vaccine products which is engulfing the world's people, most recently with the unprecedented plan to jab the entire world population with defective Covid-19 injections, over and over again.** What does the continual artificial interference with vaccine products mean for the future of the human species? Consider this alarming statement: "**We've shifted the human population...to dependency on vaccine-induced immunity...We're in a very fragile state now. We have developed a world that is dependent on vaccinations.**" This was the startling admission made by Heidi Larson, director of the Vaccine Confidence Project, at the World Health Organization Global Vaccine Safety Summit in December 2019. **This is particularly shocking to consider realising that 'vaccine-induced immunity' is failing, as evidenced by the fast-tracked experimental Covid-19 jabs.**

**Gerard, we need to talk about this urgently as a community, we need to talk about the ever-increasing vaccine load, and the impact these vaccine products are having on the natural immune response, and the long-term cumulative effects.** We should have been discussing this openly years ago, but discussion has been suppressed. Who knows how much damage has been done now with the onslaught of vaccine products?

I initiated this matter with you in **my email about the MJA article** encouraging doctors to administer Covid-19 jabs to children as young as 12 against their parents' wishes, raising the conflicts of interest of one of the authors of the article, Nigel Crawford, Chair of the Australian Technical Advisory Group on Immunisation (ATAGI), and his association with the Murdoch Children's Research Institute, which is involved in vaccine research, including Covid-19 vaccine research with the Doherty Institute. **The Murdoch Children's Research Institute is a corporate partner with News Corp Australia, a significant conflict of interest I have not seen disclosed on articles promoting Covid-19 jabs on News Corp Australia publications.**

**Gerard, the general public is largely unaware of the wide web of conflicts of interest impacting on taxpayer-funded vaccination policy,** including groups such as ATAGI, the TGA, the Pharmaceutical Benefits Advisory Committee (PBAC), National Centre for Immunisation Research and Surveillance (NCIRS), Australian Academy of Science, National Health and Medical Research Council (NHMRC) and others, and the broader international network, including the Bill & Melinda Gates Foundation, the World Health Organization, Cochrane, and the Vaccine Confidence Project etc. Lobby groups are highly influential, e.g. the vaccine industry-funded Immunisation Coalition, and Friends of Science in Medicine.

**My 2018 presentation and recent TNT interview discusses this international network, and also the influence of the Murdoch media/News Corp Australia on vaccination policy in Australia,** via the Murdoch Children's Research Institute, and also via its aggressive No Jab, No Play media campaign run in 2013-2015, resulting in the coercive No Jab, No Pay/No Play laws initiated in 2016. **Scott Morrison was Social Services Minister in 2015, and it was he who raised the No Jab, No Pay bill. It's notable that Scott Morrison had a private lunch with Rupert Murdoch in 2015 - was the No Jab, No Pay bill discussed during this meeting?** (See **my email to Scott Morrison, 18 February 2021.**)

**The 'No Jab' concept is now influencing the Morrison government's Covid-19 jab rollout,** with 'No Jab, No Job' mandates being imposed by state and territory governments, and employers and businesses, along with 'No Jab, No Restaurant', 'No Jab, No Gym', 'No Jab, No Sport...**No Jab, No Life...** **Australians are being discriminated against on the basis of 'jab status', with critical thinking people who are unable to give their informed consent to the defective Covid-19 jabs being progressively cancelled out of society. This is a disgraceful period in Australia's history, with the segregation of Australians, and millions of people being bullied into submitting to the Covid-19 jabs.**

**We must examine how this coercive vaccination policy has become so easily entrenched, illegitimately overriding 'valid voluntary consent', as outlined in *The Australian Immunisation Handbook*, i.e. "For consent to be legally valid, the following elements must be present...It must be given voluntarily in the absence of undue**

**pressure, coercion or manipulation...It can only be given after the potential risks and benefits of the relevant vaccine, the risks of not having it, and any alternative options have been explained to the person."**

AHPRA, the regulator of health practitioners, has also confirmed: "**Practitioners have an obligation to obtain informed consent for treatment, including vaccination. Informed consent is a person's voluntary decision about health care that is made with knowledge and understanding of the benefits and risks involved.**" (See copy of AHPRA letter attached.) With people being pressured and coerced to submit to the Covid-19 jabs, it appears very doubtful that authentic voluntary consent is being obtained by health practitioners administering the jabs. In this regard, please see my email to Karen Price, President of the Royal Australian College of General Practitioners: **Covid-19 jab mandates overriding 'valid voluntary consent'**, 1 March 2022.

**Also included in my 2018 presentation and TNT interview is reference to people who are still influential on vaccination policy**, e.g. Terry Nolan who was Chair of ATAGI for the period 2005 to 2014, and is currently associated with the Murdoch Children's Research Institute; Robert Booy who is affiliated with the National Centre for Immunisation Research and Surveillance (NCIRS), and a director on the board of the vaccine industry-funded Immunisation Coalition; Helen Marshall who is the lead investigator on the GlaxoSmithKline-funded Bexsero meningococcal B vaccine trial in South Australia, and who was also a member of ATAGI while running this trial; and Andrew Pollard who is the Director of the Oxford Vaccine Group, and was involved in the development of the Bexsero meningococcal B vaccine. **Andrew Pollard is now a major player in the international Covid-19 'vaccine' response as he is the Chief Investigator on the Oxford/AstraZeneca vaccine trials, while also being Chair of the UK Joint Committee on Vaccination and Immunisation. Andrew Pollard was until recently a member of the World Health Organization's Strategic Advisory Group of Experts on Immunization (SAGE), until December 2021.**

Gerard, I hope you will consider the information provided in my 2018 presentation and recent TNT interview. It's because there has been so little transparency and accountability for taxpayer-funded vaccination policy in the past that we are in this dire position today, with vaccination policy out of control, as is evident with the grossly disproportionate and ill-targeted mass population Covid-19 jab rollout.

**Vaccination policy and practice has become unquestionable dogma, aka the 'Church of Vaccination'.** People are forbidden to question vaccination in serious public debate, with people challenging vaccination policy reflexively being labelled 'anti-vaccination', and marginalised and shut down. This silencing of debate has been extremely damaging. Vaccination is a medical intervention, not a therapeutic, but a 'preventative', which is pressed upon mass populations of people who may never have been at serious risk of the designated disease, as we're now seeing with Covid. **The over-use of antibiotics, anti-depressants, and opioids and other medical products is acknowledged, but people questioning the ever-increasing number of vaccine products and revaccinations are shut out of the conversation.** I've been trying to raise the alarm about the over-use of vaccine products and conflicts of interest in vaccination policy for years, but I'm usually ignored or fobbed off with form letters from politicians and others. Trying to discuss this issue in the public arena is very difficult, and I've been banned from commenting on articles on the university-funded *The Conversation*, the UK *Telegraph*, and other websites, plus often censored on *The Australian*.

**There should be accountability for taxpayer-funded vaccination policy to the Australian public** but, instead, mandated vaccine products for children, and now mandated Covid jabs for many people across society, are being foisted upon the community, trashing the principle of 'valid voluntary consent' before this medical intervention. **Health practitioners in particular are in a highly conflicted position.** On the one hand they have a duty to obtain valid voluntary consent before vaccination, but on the other they are constrained from challenging the vaccination status quo, with any questioning of vaccine products seen to be 'anti-vaccination' and potentially "**in breach of the codes of conduct and subject to investigation and possible regulatory action**". In other words, **doctors and nurses are at risk of being struck off if they question the dominant vaccination narrative.** The general public would surely be alarmed if they were aware health practitioners are being threatened from questioning vaccination policy and practice. (See for example the AHPRA Position Statement - **Registered health practitioners and students and COVID-19 vaccination**, 9 March 2021, copy attached.)

**This situation is extremely serious Gerard. Children in particular are bearing an ever-increasing vaccine load, and now they're being set up for potentially a lifetime of Covid jabs...against a disease that isn't a serious threat for most people, certainly not children.** See the current **National Immunisation Program Schedule** for more information on the vaccine products being pressed upon people of all ages. Children are facing more than 50 doses of vaccines throughout childhood, including via multi-component shots, and revaccinations. The vaccination schedule is from cradle to grave, in fact it starts in utero, with pregnant women being urged to have an increasing number of vaccine products, i.e. influenza, pertussis and now Covid, and with respiratory syncytial virus vaccination potentially looming in future.

As I note in my 2018 presentation, I started investigating vaccination of pets in 2008, after one of my dogs became very ill and was put down after what I subsequently discovered was gross over-vaccination with modified live virus and inactivated vaccine products. World Small Animal Veterinary Association dog and cat vaccination guidelines originally published in 2007 **warned to reduce the 'vaccine load' on individual animals to minimise the risk of adverse reactions. Yet vaccination of humans is going through the roof!** An extraordinary number of vaccine products are pressed upon people now, with many more in the pipeline. (Re pet vaccination, please see attached an

article published in CHOICE in 2010: **Over-vaccinating your pet could be harmful to their health as well as costing you money unnecessarily**, which includes my experience with my dog. There was widespread coverage of the over-vaccination of pets story in the mainstream media at the time, see for example this article published on the ABC: **Vets accused of over-vaccinating pets**, copy attached. Over-vaccination is now rife in the human population.)

**Gerard, the world is facing a real emergency with the gross over-use of vaccine products. The important subject of taxpayer-funded vaccination policy must be on the table before the federal election, likely in May 2022.**

Please also refer to **my recent email to senator Alex Antic** re the Australian public being grossly misinformed about the Covid-19 situation via fear-mongering government propaganda being pumped out by the mainstream media, with defective Covid-19 jab promotion being paid for with taxpayers' money.

**After all the years of suppression and censorship, the spotlight must now be shone on taxpayer-funded vaccination policy, starting with critical examination of the Morrison and state and territory governments' mass population Covid-19 jab rollout.**
