I've just left a comment on Ian Brighthope's recent substack article: [The largest medical vaccination scandal from Mr. Gebreyesus and the WHO is now contradicted by EU Members of Parliament and the European Medicines Agency, the EMA](#)

Event 201, hosted by the Johns Hopkins Center for Health Security in partnership with the World Economic Forum and the Bill and Melinda Gates Foundation.[2]
